ABOUT THE AWARD



The Prime Minister's Hibiscus Award (PMHA), originally known as the "Hibiscus Award," was launched in 1996 and renamed in June 1998 with the approval of the then Prime Minister, YAB Tun Dr Mahathir Mohamed, reflecting its elevated prestige and national significance.

OVERVIEW

Business and industrial sectors are principal sources of investment and drivers of economic growth. They are rightfully the key players in ensuring the protection of the environment to support and promote the environmental, social and economic pillars of sustainability. This Award presents an opportunity for public recognition of business and industry's environmental accomplishment and leadership as well as serves to promote and environmentally conscious culture while pursuing economic growth.

The Award is jointly organised by three of Malaysia's leading private-sector non-profit organisations dedicated to advancing corporate environmental responsibility, namely:

AIMS AND OBJECTIVES



This award aims to give due recognition to businesses and industries that are committed to protecting the environment and demonstrate effective environmental management as part of meeting their corporate objectives.

The Award assists enterprises in identifying areas for improvement to address current and future environmental issues to ensure their resilience. Additionally, this initiative serves as an indirect facilitator of capacity building and partnership development. This will prove vital in tackling increasingly stringent environmental requirements and challenges on a global scale.

Participation in the award will allow businesses and industries to demonstrate their environmental commitments to stakeholders who are interested in understanding the participants' sustainability journey and contribution to sustainable development.

THE SPECIFIC OBJECTIVES OF THE AWARD ARE TO :

- Grant businesses and industries alike with the opportunity to gain independent evaluations of their environmental commitments as well as their management approaches and performance.
- Prompt business and industries to engage proactively in sustainable environmental management practices; and
- Acknowledge the achievements of participating organisations and promote them as a corporate yardsticks to emulate.

CATEGORIES OF AWARDS



Recipients of the Prime Minister's Hibiscus Award will receive recognition for their environmental performance and commitment, determined through a two-stage assessment. The recognition is based on three levels of achievement and awards, arranged in ascending order to denote increasing levels of accomplishment. These levels of achievement and awards are as follows:

- EXCELLENT ACHIEVEMENT in Environmental Performance
- EXCEPTIONAL ACHIEVEMENT in Environmental Performance
- NOTABLE ACHIEVEMENT in Environmental Performance
- SME SPECIAL AWARD will honour the top-performing SME participant
- STATE AWARDS will recognize the best participant from each state.
- SPECIAL PROJECT AWARD Large Enterprise
- SPECIAL PROJECT AWARD Small/Medium Enterprise
- In addition to these awards, a CHALLENGE TROPHY will be awarded to the awardee with the highest overall performance for the cycle.

BENEFITS TO THE AWARDEES

Recipients of the Prime Minister's Hibiscus Award will receive the following :

- Recognition for outstanding commitment to environmental management as an exemplary organisation
- Presentation of a plaque and certificate of participation
- Authorisation to utilize the award's logo for promotional purposes
- One complimentary seat to attend a one-day seminar, briefing, or **workshop on sustainable development** hosted by each organiser, FMM, MICCI, **ENSEARCH**, valid until the conclusion of the next award cycle.

INDUSTRY COVERAGE



Participation is open to all Industrial and Services sectors. Within each Industry and service group, there will be 2 categories of participants: Large Enterprises and SMEs. This sub-division levels the playing field and eliminates disparate comparisons between industries. The sub-division is determined by the annual sales turnover and number of employees:-

1. LARGE ENTERPRISES (LE)

a. Manufacturing (including Agro-Based) & Manufacturing - related services

Companies with full-time employees exceeding 200 and with annual sales turnover exceeding RM50 million.

b. Service Sector (including ICT)

Companies with full-time employees exceeding 75 and with annual sales turnover exceeding RM20 million.

2. SMALL AND MEDIUM ENTERPRISES (SME)

a. Manufacturing (including Agro-Based) & Manufacturing - related services

Companies with full time employees NOT exceeding 200 OR with annual sales turnover NOT exceeding RM50 million.

b. Service Sector (including ICT)

Companies with full time employees NOT exceeding 75 OR with annual sales turnover NOT exceeding RM20 million

ELIGIBILITY

Enterprise that are free from any DOE violation/compound.(compound to be settled before Stage I submission)



ORGANISATION OF THE AWARD

The Award Organizing Committee (AOC) evaluates companies' overall commitment to reducing their environmental impact. This approach is in line with the principles of the International Chamber of Commerce (ICC's) Business Charter for Sustainable Development and environmental management systems standards, such as the ISO 14000 series. Comparing each applicant company's commitment against the award criteria allows the AOC to select the most deserving winners.

To ensure the award maintains the highest standard, the AOC has established a Technical Committee (TC) responsible for developing and implementing the award methodology. This committee is supported by experts with extensive experience in environmental management systems and auditing, drawn from Malaysia's leading companies in environmental management. Ultimately, the AOC makes decisions on the winning companies based on the findings and recommendations of the TC and expert panel.

ASSESSMENTS

The successful implementation of the Prime Minister's Hibiscus Award relies on the simplicity and clarity of its assessment criteria's whilst emulating the latest trends in environmental management practices.

THE ASSESSMENT IS CARRIED OUT IN TWO STAGES:

STAGE I: Submission of a written questionnaire by the participating Company. The responses are evaluated against a set of criteria drawn up by the TC.

STAGE II: Site visit to verify Stage I submission and the company's environmental performance and commitment.

Participants short-listed for Stage II are required to provide additional facility information if necessary (e.g. site layout, history and etc) for the site visit. A team of not less than two assessors will assess each site.

Site Visits will be conducted over a period not exceeding two days. Following the assessment the participants will be debriefed on the results of the assessment in line with the guidelines.

STAGE I - ASSESSMENT OF SUBMISSION



THE STAGE I Questionnaire requires the company to provide information in fourteen broad areas. These areas are based on some key principles issued by the International Chamber of Commerce (ICC's) Business Charter for Sustainable Development and are:

1. Leadership, priority and commitment
2. Managing environmental issues
3. Training and communication
4. Legal and other compliance
5. Environmental emergencies
6. Environmental improvement
7. Product / service communication
8. Employee Participation
9. Supply chain
10. Environmental social programme
11. Environmental accounting
12. Life cycle analysis
13. Eco - design
14. Eco – labelling
15. Carbon Footprint

The above cover a broad range of environmental issues that companies should be addressing. Each heading is provided a numerical score which allows the TC to carry out the initial screening of applications and to select the companies that will proceed to **STAGE II**.

A company does not have to score highly in every section. The Questionnaire has been designed to be flexible so that weakness in some areas can be counterbalanced with strengths in other areas.

STAGE II - SITE ASSESSMENT OF SHORTLISTED PARTICIPANTS



Members of the expert panel assigned by the TC will visit the companies that have met the relevant criterias prescribed in Stage 1.



The site visits will be limited to a maximum of two days per site, The accuracy of the written submission in Stage 1 will be verified by a team of no more than three assessors who will tour the site as well as interview the relevant personnel at the site in question.



A confidential assessment report for each site visited will then be produced based on this site assessment. The report is an internal Hibiscus Award document and will not be made available to the company or any third party.



The Award holds true to its commitment to excellence and professionalism. Submissions to Award Organisers will be treated in the strictest confidence and will not be disclosed to any third parties.



The site management will be debriefed at the end of the site assessment. The relevant findings and recommendations by the TC will be used to determine the decisions taken by the AOC
